



CONSTITUTION OF ASSOCIATION OF CHHATH PUJA SEVA SAMITI PONDA-GOA


1. **NAME OF THE SOCIETY SHALL BE:** "Chhath Puja Seva Samiti Ponda Goa".
2. **DEFINITIONS:**
 - a) Society means: " Chhath Puja Seva Samiti Ponda-Goa"
 - b) Committee means: Executive Committee.
3. **Office:** Presently the office of the society shall be situated at Room No A-215,2nd Floor, Heritage Princess, Opposit Almeida High School, Warkhande, Ponda, Goa-403 401.It may be changed any where in Goa if Samiti desires so through its General Body Meeting.
4. **OBJECTIVES OF THE SOCIETY:**
 - a) To promote and practise of all type of rich cultural heritage activities related to Chhath Puja
 - b) To promote personal and friendly relations among the members of the samiti
 - c) To help its member to defend their moral, economic and social interest.
 - d) To organise cultural programmes

Members of the society

5. All the persons with good character shall be eligible for the membership of Chhath Puja Seva Samiti.The member must be dedicated towards Chhath Puja and it's related activities.

Membership

6. The society shall have the following category members.
 - a) **Founder Member:** Are those who contribute with a sum of Rs.500/- (Rupees Five Hundred only) at the time of formation of this society in the year 2013 as a founder member.This is applicable for the year 2013 only.After 2013 new members can be inducted as ordinary member. Founder Members will be contributing a sum of Rs 500/- as annual subscription fee and same to be deposited in Corpus Fund of Samity.
 - b) **Ordinary Members:** Are those who contribute with Rs.500/- (Rupees five hundred only) after formation of Samiti and desires to become ordinary member of the samiti.An annual subscription of Rs 500/- towards Corpus Fund of Samiti has to be made by ordinary member.
 - c) **General Members:**Are those who contribute Rs 50/-(Rupees fifty only) every month after formation of samiti and desires to become General Member.
 - d) **Patron:** A person who has contributed Rs.21,000/- (Rupees twenty one thousand only) at one time and desires to become patron of the samiti.
 - e) **Life Members:**Are those who contribute Rs 11,000/- (Rupees eleven thousand only) at one time and desires to become Life Member of the samiti.
 - f) **Nominated members:** A person who has been nominated by the Executive committee for specific period for guidance & co-operation if necessary.



7. The members will not have the right to ask for refunding the money contributed, in case of dismissal of membership or when he ceases to be member of its own record.
8. The members who may distinguish themselves by their services to the samiti will be compensated with the followed commendation.
9. Election will be held by raising hand or secret ballot paper.
10. The income of the samiti will consist of:
 - a) Membership fees, income from feasts and other activities.
 - b) Grants, donations and income from any other sources.
11. The committee shall have the discretion to accept or reject any application for membership and they are not bound to give any reason or reasons for the rejection of the application.

12. Rights & duties of the members:

- a) To visit the headquarters of the samiti.
- b) To take part in all activities of the samiti.
- c) To be present for the meeting of the general assembly taking part in discussions & voting & to elect for the executive committee, other committees.
- d) To examine & appreciate the annual statements of accounts in that meeting of the general assembly.
- e) To call meeting of the general assembly being the petition for this signed by at least 20 members & addressed to the president of executive committee.
- f) To pay their monthly fee regularly.
- g) To hold the posts for which they are elected when they are disable from doing so by some acceptable reason.

13. Resignation By A Member:

- a) Whenever a member of the society desires to resign, he shall forward an application to this effect to the president of the society, if the resignation is accepted by the committee.
- b) The members will not have the right to ask for refunding the money contributed, in case of dismissal of membership or when he ceases to be member of its own record.

14. Expulsion of members & penalties:

- a) A member who does not pay during consecutive month the membership fees shall forfeit the right to the respective privileges.
- b) A member shall be likewise relieved & prohibited to visit headquarters of the samiti in the following cases:
- c) If the member violates the rules or private regulation of the society.

15. The income referred in the precious article shall be deposited in a bank selected by the General Assembly & its Secretary & Treasurer.

16. The present regulation of the samiti can be altered totally or partially by the approval of the General Assembly.

17. Any amendments to this rule will have to propose and second by two members and notice must be given to the assembly and copy of it should be an affixed on the notice board 8 days before the meeting.



18. General Body & Executive Committee:

The annual General Body of all the members & elected Executive Committee of 12 members will not be the members of the Executive Committee for more than 3 years.

19. General Body Meeting:

The general assembly shall be composed of all members in full exercise of their right. The meeting shall be hold twice per year.

- a) The General Assembly shall have extraordinary meeting when the president thinks it necessary when the Executive committee or the Auditor committee ask for it or when minimum 20 or more members apply for it.
- b) The Quorum for the meeting of the General Assembly is 2/3rd or 12 members whichever is less.

- c) When the General Assembly meeting cannot be constituted at the first convocation as per rules it shall be considered to be constituted at the second meeting with any of member, after a period of one week.
- d) The Governing body of the General Assembly shall be composed of President, Secretary.
- e) The member will be notified regarding the locality time and agenda of the meeting.

20. Function Of General Body Meeting:

- a) To elect the Governing Bodies of the General Assembly and the members of the Executive Committee.
- b) To examine and approve the report and statement of Accounts put up by the executive committee and to study the acts of the governing bodies.
- c) To impose the penalty or expulsion.
- d) To deal with matters pertaining to the administration of the samiti when placed before it by the executive committee.

21. The Annual General Meeting of the society may be convened by giving at least 15 days notice in advance to all the members of the society. Such notice be displayed in the society's office.

22. Special General Meeting of the society may be convened by the secretary on a intimation from the president or 3 members of the committee or 2/3rd members of the society by giving at least 5 days notice in advance to all procedure specified in Article 16.

23. The proceeding of the General Body Meeting shall be written in the minute book & shall be endorsed by the secretary & the president. Signature of the members present at the meeting shall be also recorded in the minute book. In case of equal members of Votes president shall have right for deciding vote in addition to his ordinary vote.

24. 2/3rd of the total members of the society or 12 whichever is less shall form the quorum at the general body meeting. If this is in adequate the meeting shall be adjourned for half an hour & resolution passed at such adjourned meeting shall be valid. Quorum shall not be taken into consideration at such meeting.



Executive Committee

- 1) The Executive committee shall consist of the eleven members viz President, two Vice Presidents, General Secretary, Asst Secretary, Treasurer and 5 members.
- 2) The Executive committee shall manage the affairs of the Samiti according to its rules.
- 3) A Chartered Accountant shall be appointed by the Executive Committee as the auditor every year on completion of financial year that is from 1st April to 31st March accounting year to audit the account of Samiti.
- 4) The election for the Governing Bodies shall take place in General Meeting by secret ballot considering as elected the members, who secure majority of votes.
- 5) In case of equality of votes the senior members shall be considered elected.
- 6) The Governing Bodies shall hold their posts for a period of three years.

Function of the committee:

25. To scrutinize application for membership & admit patrons, life members of the society, also to appoint a nominated members in the Executive Committee.

26. To appoint, dismiss any employee of the society.

27. To raise funds by the legal means as committee think fit.

28. To collect & deposit the amount received in the bank from the various institutions, run by society.

Function of the President:

29. To fix date & timing of the meeting & to call the same through the secretary general body meeting & of the committee whenever necessary.

30. To direct the matters of the society.

31. To look after correspondence of the society.

32. To preside over the general body meeting & of the society & meeting of the committee.



Function of Vice President

33. In absence of President Vice President will perform duty of President.

Function of the General Secretary:

34. To convey the meeting of the Executive Committee & the General Body Meeting on intimation from the president.

35. To write the proceeding of the general Body Meeting & the Executive Committee in the minute books.

36. To look after the property of the society in good order.

37. To carry out correspondence of the society.

38. To prepare & read annual report of the General Body Meetings.

Function of Asst Secretary

39. In absence of General Secretary Asst Secretary will perform function of General Secretary.

Function of the Treasurer:

40. To sign the receipt of the subscription & other receipts of the society.

41. To maintain the accounts of receipt & expenditure of the society, educational institution & the libraries.

42. To maintain membership book & subscription book with necessary details.

43. To deposit money in the Bank, to receive interest.

44. To operate Bank Account of the society on behalf of the President & Secretary.



Dissolution of Society

45. In the event of dissolution of winding up of the society, the assets remaining as on the date of dissolution will under no circumstances be distributed among the members of Executive Committee/Governing body but the same will be transferred to another society whose objects are similar to those of this society & which is duly registered under societies registration act & enjoy recognition under section 80G of the income tax act 1961 as amended from time to time.

A special notice should be given & the general body meeting has to be called minimum 3/5th members of the total members must vote in favour of the motion then only the society will be dissolved keeping in view provisions of the societies Registration Act 1860.




Amendments
